**Education and Training:** Both Linda and Kurtis were trained in hypnotism through the National Guild of Hypnotists. We are Certified Members and do annual continuing education to maintain our training at a high level. Our credentials are (CH) Certified Hypnotist.

**Fees:** The charge for our services is \$99.00 per session. The first session is \$149.00 which includes a complete Intake Assessment. You will be given a 14 day notice of any changes in fees. We **do not** accept insurance coverage.

**Confidentiality:** We will not release any information to anyone without a written authorization from you, except as provided for by law. You have a right to be allowed access to my written record about you.

**Insurance:** We suggest you think of our services as something that you will pay for personally. That will both protect your privacy and help you value the work you are doing more. In general, insurance companies do not like to cover hypnotic services, and I caution you not to expect them to do so.
